Communication Expectations: The course information will be posted on Canvas. All homework assignments, review sheets and other course information will be posted there. Students can ask questions and communicate with me through the Canvas email.

Course Description

First semester of the core graduate topology course. Some of the topics to be studied in this sequence are as follows. Topological spaces are introduced along with specific instances such as metric spaces and order topologies. Bases and subbases are studied and used to define topological spaces. Subspace, quotient and product space constructions are studied. Countability and separation axioms are introduced and studied along with strong and weak topologies. Embedding and metrization theorems are covered and also related topics such as the Tietze extension theorem. Ordinals are introduced and studied as a topological space. Compactness and its variations are considered, and the Tychonoff theorem and Alexander subbase theorem are proved. Sequences, nets, filters and ultrafilters are studied. Compactifications (one-point and Stone-Cech) are introduced and studied. Connectedness and local connectedness are studied. Baire category and category methods are introduced and used. Other topics as time permits.

Course Structure

The course meets face-to-face, Tu, Th 11:00-12:20 in Gab 461. If I need to go out-of-town on some days, the class will meet on Zoom those days. The Zoom ID for these meetings is: Zoom ID 876 1489 5846.

Course Objectives

This course will develop the theory of topological spaces which is important for many areas of mathematics. This is a core graduate course sequence which will prepare students for the topology qualifying exam.

Materials

The textbook for the course is **Topology** by **Stephen Willard**. It is available through Dover publications.

Course Requirements

There will be two tests in the course as well as a final exam. There will be more or less weekly homework assignments which be collected and graded. While class participation is not explicitly counted, such participation may factor into the final grade in borderline cases.

Grading

The two tests will each count 22.5% of the grade, the Final 30%, and the Homework 25%.

Course Policies

Students are expected to attend class meetings regularly. Though attendance is not explicitly counted in the grade, it may affect the letter grade assigned in borderline cases. Please inform the professor and if

Academic Integrity Policy

Important Notice for F-1 Students taking Distance Education Courses

Federal Regulation

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

- (1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.
- (2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email internationaladvising@unt.edu) to get clarification before the one-week deadline.

Transmission and Recording of Student Images in Electronically-Delivered Courses

1. No permission is needed from a student for his or her image or voice to be transmitted live via videoconference or streaming media, but all students should be informed when courses are to be conducted using either method of delivery.
